**Explanation of Responses:**

1. Shares sold pursuant to a registered underwritten public offering of Universal Truckload Services, Inc. The public offering price of the shares sold was \$26.00 per share and the underwriting discount was \$0.4458 per share. Accordingly the reporting person sold an aggregate of 1,380,000 shares of common stock and received a price per share of \$25.5542 (net of underwriting discounts and commissions) for an aggregate amount of \$35,264,801.40.

**Remarks:**

Matthew T. Moroun exercises voting and investment control over the MJ Moroun 2012 Annuity Trust, as trustee. Matthew T. Moroun is the son of Manuel J. Moroun. The Morouns vote their shares and the shares of the MJ Moroun 2012 Annuity Trust as a group for the purposes of Section 13(d) of the Exchange Act of 1934. After the underwritten public offering the Morouns own 21,544,832 shares.
